Chantelle, HR Manager, and a team of other trainees presented at a careers event held at the sixth form I attended. I always had a keen interest in business and economics and I was intrigued to find out exactly what an accountant did on a day-to-day basis. Forrester Boyd was very well-known for its trainee accountancy programme and I had heard lots positive things regarding the work, social life, and relationships that were built at the company.

During my time at sixth form, I felt very pressured to apply for University to gain a degree to develop a successful career as an accountant. ### What was your training experience like?

I studied with two different training providers, BPP and Kaplan. My exam tuition classes were based in Hull, Sheffield and Leeds and I would travel and/or stay over in a fully subsidised hotel during my leave.

The exam tuition is intense. I was used to studying hard for A Levels during my time at sixth form, but I knew I had to put the work in to pass all my accountancy exams first time. I was able to start studying for my Chartered Qualification in September 2015, where I met some very good friends who I studied with throughout my 4 years of training.

With being on the apprenticeship scheme, it meant that I also had to do some practical work experience alongside my studies. This would mean that during exam periods, I would have to revise after a day in the office and also during my weekends.

I very much enjoyed my periods studying in Hull, Sheffield and Leeds and managed to make some good friends along my journey that I wouldn't have got through my exams without.



#### What is it like working at Forrester Boyd?

There is a lot of flexibility within Forrester Boyd as staff members have the ability to work flexible hours. If I am planning a weekend trip away and wanted to leave at 4pm on a Friday, I would be able to work extra hours Monday-Thursday in order to leave early without using my annual leave allowance.
