What you need to know

From 1 April 2019 just over 1 million businesses who are registered for VAT with taxable turnover above £85,000 will need to maintain their VAT records digitally. VAT returns will also need to be submitted directly from compatible software. You **WILL NOT** be able to use the current HMRC VAT portal to input your VAT return figures, they will have to go through the new 'digital' gateway.

What you need to do

1. Register for an online Government Gateway account
2. Find out when you need to make your first MTD submission
3. Decide if you need a bookkeeper or an accountant
4. Decide how you will digitally record transactions (review your software)

Step 1 -

Step 3 -

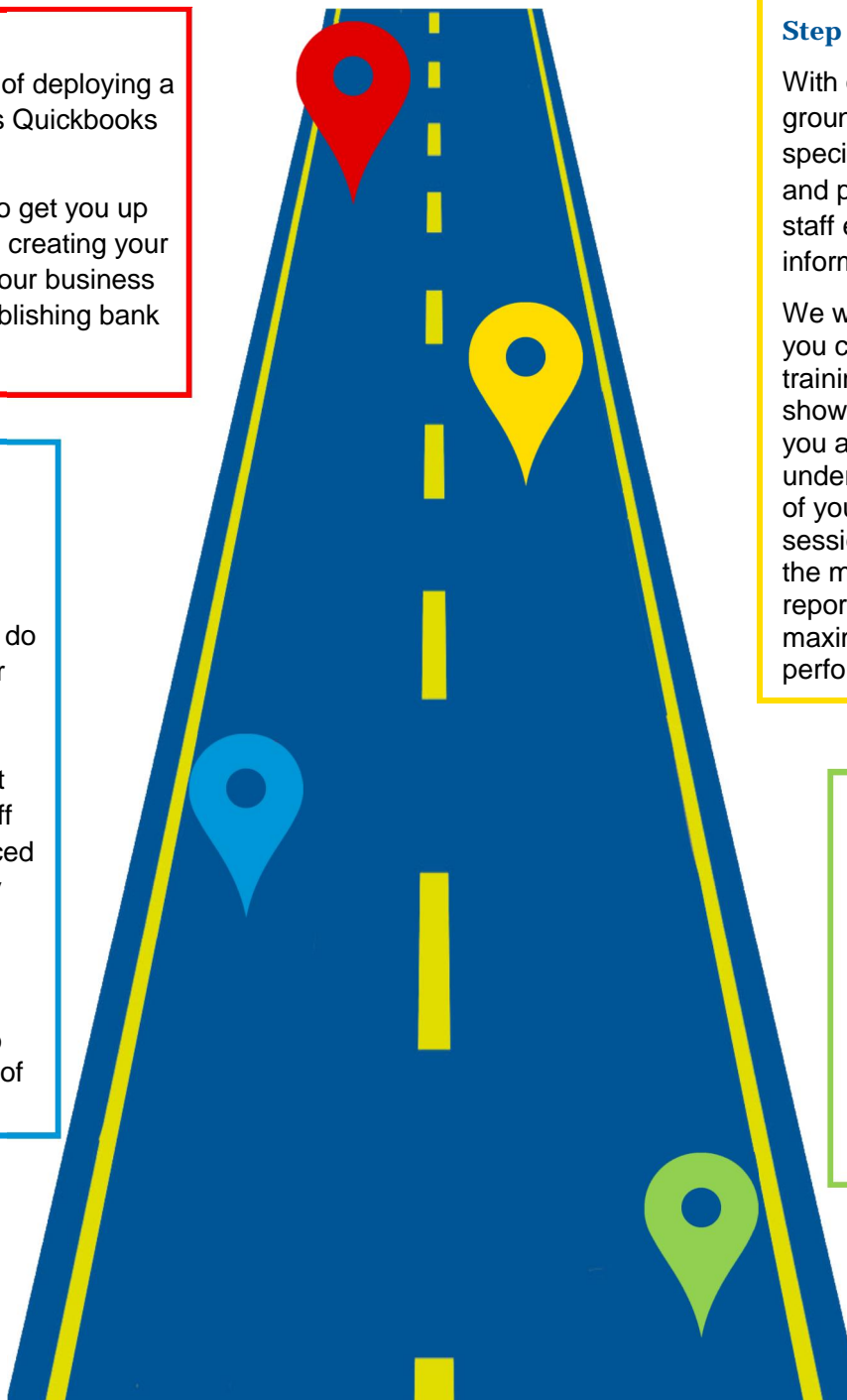
