The ability to identify and effectively resolve challenges or issues by using critical thinking, resourcefulness, and creative strategies.

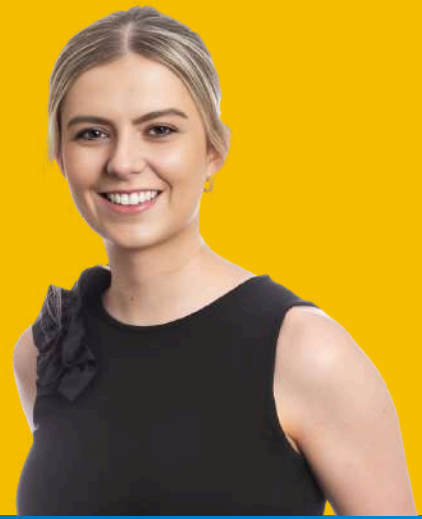
Working Under Pressure

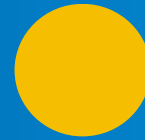

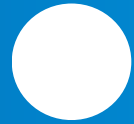

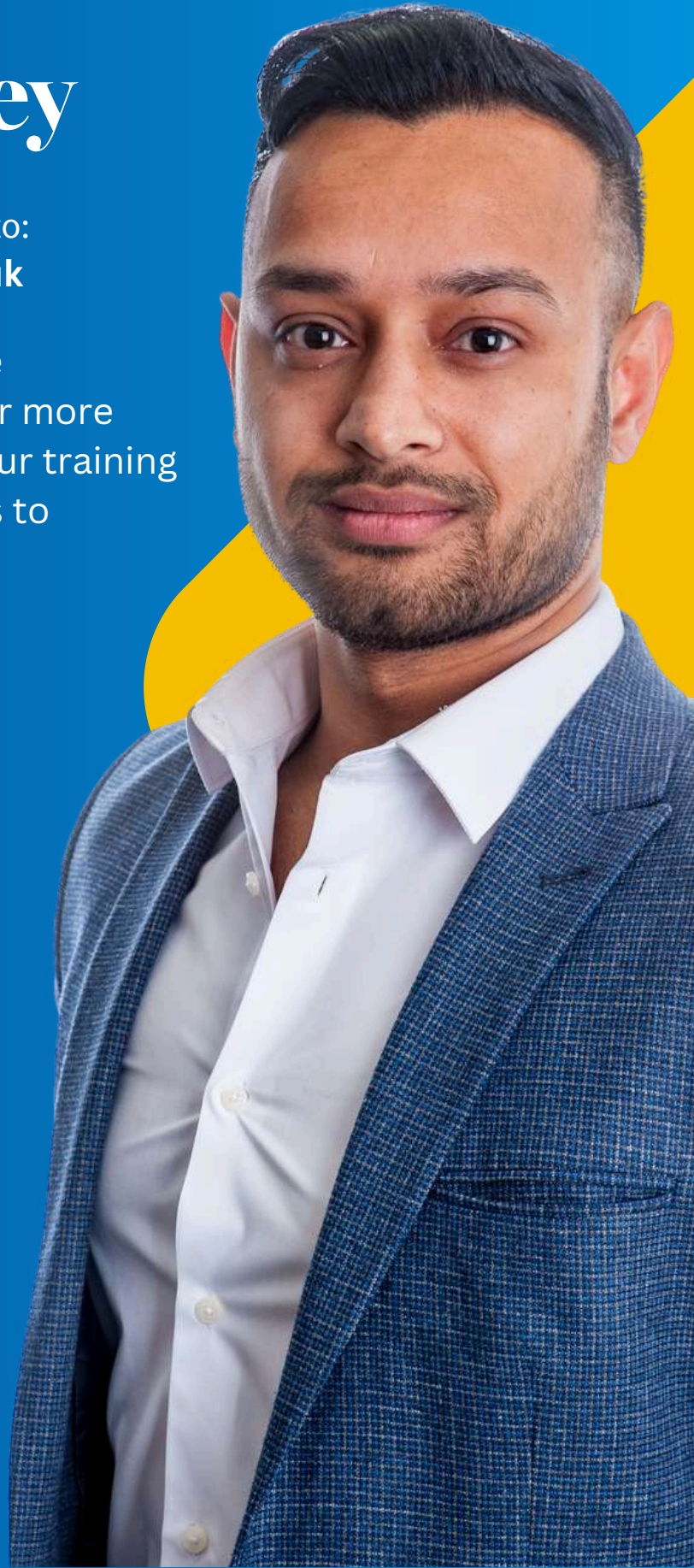
